FOR MARRIED VETERANS AND THEIR FAMILIES IN ACCORDANCE WITH OBERGEFELL;

BENEFITS TO SURVIVING SPOUSES WHOSE STATES OF RESIDENCE HAD NOT

RESPECTED THEIR MARRIAGES TO AN INDIVIDUAL OF THE SAME SEX; THE STATE

OF WISCONSIN IS NOW REQUIRED TO ISSUE ACCURATE BIRTH CERTIFICATES

LISTING BOTH PARENTS FOR THE CHILDREN OF MARRIED SAME-SEX COUPLES; AND

SIMILAR RELIEF WAS OBTAINED FOR SAME-SEX COUPLES IN NORTH CAROLINA WHO HAD CHILDREN AFTER THEY MARRIED. SIMILAR LITIGATION IS PENDING IN SOUTH CAROLINA AND FLORIDA.

WE CONVINCED THE HIGH COURTS OF BOTH KENTUCKY AND NEW YORK TO RESPECT PARENTING RIGHTS OF THOSE WHO HAD BEEN IN SAME-SEX RELATIONSHIPS. IN KENTUCKY, THE COURT RULED THAT OUR CLIENT HAD A RIGHT TO CHALLENGE AN EFFORT OF THE MAN HER EX-PARTNER SUBSEQUENTLY MARRIED TO ADOPT THE CHILD BORN DURING THE TWO WOMEN'S RELATIONSHIP AND JOINTLY RAISED BY THEM. IN NEW YORK, THE COURT HELD THAT, IF AN UNMARRIED SAME-SEX COUPLE AGREED TO CONCEIVE AND RAISE A CHILD TOGETHER, THE PARTNER WHO DID NOT GIVE BIRTH CAN SEEK CUSTODY AND VISITATION WITHOUT HAVING ADOPTED THE CHILD.

CONTINUING OUR EFFORTS TO SECURE FURTHER CASE LAW ACCEPTING THAT THE FEDERAL STATUTE BARRING EMPLOYMENT DISCRIMINATION ON THE BASIS OF SEX NECESSARILY ENCOMPASSES DISCRIMINATION AGAINST LESBIANS, GAY MEN, AND BISEXUALS, WE CONVINCED THE FULL SEVENTH CIRCUIT COURT OF APPEALS TO REHEAR OUR APPEAL ON BEHALF OF AN INDIANA LESBIAN PROFESSOR. WE ALSO APPEALED DISMISSAL OF A SUIT FILED BY A GEORGIA LESBIAN SECURITY GUARD AND SUBMITTED NUMEROUS FRIEND OF THE COURT BRIEFS IN SUPPORT OF OTHER APPEALS. WE BROUGHT SUIT ON BEHALF OF A LESBIAN RESIDENT OF A SENIOR HOUSING FACILITY REGARDING DISCRIMINATION AND HARASSMENT SHE HAS BEEN SUFFERING THERE. WE FURTHER OBTAINED A DETERMINATION FROM THE EEOC THAT A MAN LIVING WITH HIV WAS UNLAWFULLY DISCRIMINATED AGAINST WHEN HIS OFFER TO BECOME A LOUISIANA DEPUTY SHERIFF WAS RESCINDED AFTER A POST-OFFER MEDICAL EXAM DISCLOSED HIS HIV STATUS.

WE CHALLENGED THE NORTH CAROLINA LAW THAT BARS TRANSGENDER PEOPLE FROM USING RESTROOMS AND OTHER SINGLE-SEX FACILITIES THAT DO NOT MATCH THE GENDER LISTED ON THEIR BIRTH CERTIFICATE AND OBTAINED A PRELIMINARY INJUNCTION BARRING THE STATE UNIVERSITY FROM ENFORCING THAT LAW AGAINST OUR CLIENTS PENDING TRIAL. WE ADDITIONALLY SUED A PENNSYLVANIA SCHOOL DISTRICT THAT ADOPTED A SIMILAR POLICY. WE APPEALED TWO COURT ORDERS WRONGLY DENYING TRANSGENDER INDIVIDUALS THE NAME CHANGES THEY SOUGHT IN GEORGIA. WE SUED THE MISSOURI PRISON SYSTEM ON BEHALF OF A WOMAN DENIED NECESSARY MEDICAL CARE BECAUSE SHE IS TRANSGENDER, AND OBTAINED AN ORDER THAT A TRANSGENDER WOMAN WHO HAS BEEN REPEATEDLY SEXUALLY ASSAULTED IN THE TEXAS PRISON SYSTEM BE KEPT IN THE UNIT FOR VULNERABLE PRISONERS PENDING RESOLUTION OF OUR LITIGATION.

WE HELPED SUCCESSFULLY BEAT BACK ANTI-LGBT BILLS IN GEORGIA, INDIANA, SOUTH CAROLINA, TEXAS, AND ELSEWHERE, AND SUBMITTED FRIEND-OF-THE-COURT BRIEFS IN SEVERAL CASES OPPOSING EFFORTS TO EXCUSE ANTI-LGBT DISCRIMINATION ON THE GROUND THAT IT WAS RELIGIOUSLY MOTIVATED.
